#### 4. First-aid measures

#### 5. Fire-fighting measures

#### 6. Accidental release measures

### Precautions for safe handling

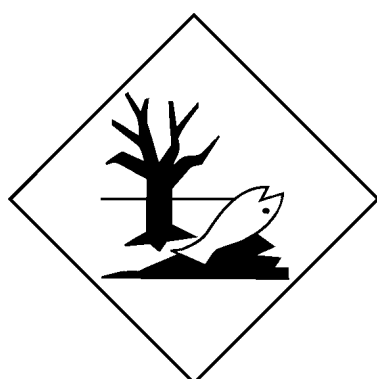
